Want to save money to start your own business, move in to an apartment, or attend college ?

Boost your savings with the Community Action IDA Program

Earn \$3 for every \$1 you save!



What is Community Action's Individual Development Account (IDA) Program?

With Community Action's IDA Program you can receive \$3 for every \$1 you save for your college education or job training, or starting or growing a child care business, or saving for your primary rental apartment move in costs.

You may save up to \$2,000 in your account and receive up to \$6,000 in match money, giving you a total of \$8,000 to invest in your goal!




To qualify, you will:

- Have earned income in the household
- Not exceed the household income limit
- Have a Net worth of less than \$20,000 (not including one vehicle and one home)
- Be willing and able to save at least \$25 per month for at least 6 months
- If you are eligible for Temporary Assistance for Needy Families (TANF) or the Earned Income Tax Credit (EITC), you may automatically qualify


