EARLY CHILDHOOD EDUCATION ENCOMPASSES CAO'S HEAD START AND EARLY HEAD START PROGRAMS. \* HEAD START IS FUNDED FOR 821 PRIMARILY LOW-INCOME PRE-SCHOOL CHILDREN, AGES 3 TO 5, INCLUDING THOSE WITH SPECIAL NEEDS, AND STRIVES TO PREPARE THEM FOR SUCCESS IN SCHOOL AND LIFE. CHILDREN WERE IN THE FOLLOWING MODELS: 719 IN PART-DAY PRE-KINDERGARTEN; 80 IN FULL SCHOOL DAY-FULL SCHOOL YEAR; 18 IN FULL-DAY FULL-YEAR; AND 4 AT COFFEE CREEK CORRECTIONAL FACILITY.
